

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.truthfamilyfarms.com and Truth Family Farms, LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Truth Family Farms, LLC include www.truthfamilyfarms.com and Truth Family Farms. The Truth Family Farms website is a ecommerce site. By using the Truth Family Farms website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, Truth Family Farms may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

If you purchase Truth Family Farms's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the Site. These may include: (a) registering for an account on our Site; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services on our Site. We also may gather additional personal or non-personal information in the future.

Use of your Personal Information

Truth Family Farms may also use your personally identifiable information to inform you of other products or services available from Truth Family Farms and its affiliates.

Sharing Information with Third Parties

Truth Family Farms does not sell, rent or lease its customer lists to third parties.

Truth Family Farms may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to Truth

Family Farms, and they are required to maintain the confidentiality of your information.

Truth Family Farms may disclose your personal information, without notice, if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on Truth Family Farms or the site; (b) protect and defend the rights or property of Truth Family Farms; and/or (c) act under exigent circumstances to protect the personal safety of users of Truth Family Farms, or the public.

Tracking User Behavior

Automatically Collected Information

Information about your computer hardware and software may be automatically collected by Truth Family Farms. Security of your Personal Information

Truth Family Farms secures your personal information from unauthorized access, use, or disclosure. Truth Family Farms uses the following methods for this purpose:

- SSL Protocol

- Detect security incidents, protect against malicious, deceptive, fraudulent, or illegal activity; or prosecute those responsible for that activity;
- Debug to identify and repair errors that impair existing intended functionality;
- Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law;
- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
- Comply with an existing legal obligation; or
- Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information.

Children Under Thirteen
